# THE EUTICK MEMORIAL STILL LIFE AWARD 2009

Coffs Harbour Regional Gallery invites all artists who reside in Australia to submit still life paintings in the Eutick Memorial Still Life Award, EMSLA. The award promotes excellence and innovation in Australian still life. The major award of \$15,000 is acquisitive. Acquisitions from the EMSLA enter Coffs Harbour Regional Gallery collection.

## CONDITIONS OF ENTRY

1. Entries: Artists may enter up to two paintings, not pastel, completed within the last 12 months. The artist must submit a CD containing an image equivalent to a jpeg or tiff file of 15 x 20cm at 300dpi, of each work that they wish to enter.

**The CD must be accompanied by the entry form and fee and reach the Gallery no later than Friday 7 August.**

2. Selection of Works: A selection panel will view all visuals and select works for the exhibition.

**Notification of selection and non-selection will be posted by 4 September 2009.**

3. Fees: The non-refundable entry fee of \$30.00 per entry must accompany the entry form. All fees include GST. Cheques/money orders are to be made payable to Coffs Harbour City Council. The receipt for the entry fees will be posted with the selection notification.

4. Delivery of Artworks: Works selected for exhibition are to arrive at the Gallery no later than **Friday 2 October 2009** addressed to:

Coffs Harbour Regional Gallery, Rigby House, Cnr Coff and Duke Streets, Coffs Harbour, NSW, 2450.

5. Transport and Insurance: Forward and return freight is the responsibility of the exhibitor. All transit insurance forward and return is to be borne by the entrant. Australia Post is not available for return of works. The Advisory Committee, Coffs Harbour Regional Gallery or Coffs Harbour City Council, accepts no liability for loss or damage during transit. Insurance whilst the works are on exhibition will be covered by Coffs Harbour Regional Gallery.

6. Labelling: All works must be clearly labelled on the back with the artist's name, address, telephone number, title of work, date of work, medium, dimensions in cms (height x width), directional arrow and sale price. Sale price includes 33% commission inclusive of GST.

7. Framing and Size: Stretched canvases are acceptable. Only works with 'D' hooks will be installed. Framed works may use perspex (no glass), or remain unglazed. Maximum dimension including framing is 200 x 150cm per entry.

8. Judging: Prior to the exhibition opening judges will view the selected works and select one entry for the major acquisitive award of \$15,000. From the remaining entries additional prizes will be awarded. The decision of the judges will be final and no correspondence will be entered into. The winning painting will become the property of Coffs Harbour Regional Gallery once the prize money is paid to the artist.

9. Results and Exhibition Opening: **The work selected for the major acquisitive award will be announced at the Official Opening on Friday 30 October 2009** at Coffs Harbour Regional Gallery.

10. Sales and Commission: All work must be for sale. Sale price includes a commission of 33% (GST included) which will be deducted from the sale price on all works sold including work acquired for Coffs Harbour Regional Gallery.

11. Promotion: Coffs Harbour Regional Gallery reserves the right to reproduce any works for archival, catalogue or publicity purposes. The signed entry form is evidence of the artist's consent.
