You may also be eligible to receive up to \$87.50 on your annual water charges and up to \$87.50 off your annual sewerage charges, if council provides these services. Alternatively, if council does not provide these services, contact your water/sewer service provider for more information.

- Holders of the PCC (Pensioner Concession Card);
- Holders of a gold card embossed with 'TPI' (Totally Permanently Incapacitated);
- Holders of a gold card embossed with 'EDA' (Extreme Disablement Adjustment);
- War widow or widower or wholly dependent partner entitled to the Pensioner Concession Card\*.
- \* If you are a war widow or widower or wholly dependent partner but do not have a Pensioner Concession Card, you should contact the Department of Veterans' Affairs (DVA) to test your eligibility for the DVA income support supplement.
