Introduction

The Annual Report refers to the period 1 July 2014 to 30 June 2015.

Section 2 of the Annual Report includes information that is prescribed by the Local Government (General) Regulation 2005. It is considered important for the community to have access to this information so it can better understand how Council has been performing both as a service provider and a community leader.

Section 1 of the Annual Report focuses on Council's significant achievements in the implementation of its Delivery Program and Operational Plan, the plans that are wholly Council's responsibility under the NSW Integrated Planning and Reporting (IPR) Framework, providing an overview of the effectiveness of Council activities in addressing the *Coffs Harbour 2030* Community Strategic Plan.

Section 3 of the Annual Report contains Council's Annual Financial Statements, as required by the Local Government Act 1993 - Section 428 (4) (a).

The Annual Report is a component of the performance monitoring provisions of the IPR legislation which also requires councils to complete a six-monthly progress report on the Delivery Program and an 'End of Term' Report at the conclusion of the term of each elected council. Community Facilities Program (2006)

In response to community demands, Council developed a \$21.5m schedule of capital infrastructure works, called the Community Facilities Program, as part of the 2006/09 Management Plan. Council applied for a special variation in rates to assist in funding the program.

On 26 June 2006, the Minister for Local Government approved Coffs Harbour City Council's application for a **9.56%** special variation to General Income for 2006/07 (see DLG Reference A49996). The approval was subject to the following conditions:

- 1. The Council will raise \$1,390,970 of the increase by additional rates for the costs associated with the infrastructure projects in Council's Community Facilities Program, and
- 2. The Council clearly report in its Annual Report for the period 2006/07 to 2015/16 information on the total income received, expenditure per project/program and outcomes achieved, and
- 3. The Council develops a comprehensive Asset Management Plan linked to a long-term financial plan. Council is to report to the Department of Local Government on the progress of the Asset Management Plan's development by 31 December 2006.

The table on the following pages provides information on the total income received and expenditure per project/program.

Outcomes Achieved

The completion of the eleven infrastructure projects from the Community Facilities Program's original schedule of works has been reported in previous Annual Reports.

Through the Community Facilities Program, the rate variation revenue has subsequently assisted in funding the upgrade of drainage at Richardson Park, the installation of lighting at Fitzroy Oval, the new Coffs Harbour Regional Museum in Harbour Drive and the new Skate Plaza at Brelsford Park.

It is also contributing funds associated with the following projects:

- Upgrade of the Woolgoolga netball courts;
- Continuation of upgrades to public amenities;
- Jetty Foreshores Revitalisation and
- The Community Capital Infrastructure Grants Program

Flood Mitigation and Drainage Works (2010)

On 24 June 2010, the Minister for Local Government approved a special variation of **7%** for Coffs Harbour City Council commencing in 2010/11.

The approval was subject to the following conditions:

- 1. The Council will raise \$1,373,358 of the increase by additional rates for the costs associated with flood mitigation and drainage works, as defined by Council; for a period of ten years; and
- 2. Council will reduce its general income for the 2021/22 rating year by \$1,373,358 plus the equivalent cumulative proportion of this increase from any general variation increases or any special variation increases approved for the 2010/11 to 2020/21 rating years inclusive; and
- 3. Council clearly reports in its Annual Report for the period 2010/11 to 2020/21 information on the total income received, expenditure per project/program and outcomes achieved.

This rate variation assists in funding a ten-year program of flood mitigation and drainage works in and around Coffs Harbour.

Funding for the program is augmented by the Stormwater Levy (Stormwater Management Charge) levied by Council.

Outcomes Achieved

The works are designed to help address a long-standing need to protect significant areas of the city from inundation and damage in times of high rainfall and extreme storm events. The necessity to fast-track these works was made clear in 2009 when the city experienced a number of flash-flooding incidents.

Work is progressing well, although land acquisition issues have slowed the pace on a number of the larger projects. Fortunately there has been no repeat of the severe weather events of 2009 however, the completed works have performed according to design in accommodating rainfall experienced to date. There is confidence that the ongoing implementation of the works program will bring a new level of flood security to Coffs Harbour.

City Centre Capital Works Program (2013-2023)

Council initiated a City Centre revitalisation program in 2000/01, funded by a twelve-year City Centre Special Rate (referred to as the CBD Special Rate). In June 2012, Coffs Harbour City Council secured approval, via the Independent Pricing and Regulatory Tribunal (IPART), to continue the CBD Special Rate in 2012/13 to allow work, including the preparation of the City Centre Masterplan, to be carried out to support an application for a further ten-year extension of the Special Rate from 2013/14.

In June 2013, Council received notification from IPART that its application to extend the CBD Special Rate for a further ten-year period from 2013/14 was approved. This approval represented an increase of **5.43%** in Council's general income for 2013/14

The approval was subject to the following conditions:

- 1. The council uses the 'Additional Income' for the purposes of funding a program of City Centre capital works, including improving City streetscapes and upgrading car parking and pedestrian and traffic flows. The program of works was listed in IPART's determination, dated June 2013. *Additional Income* means the additional general income generated above the rate pegging increase allowance.
- 2. The council reports in its Annual Report for each rating year over the period from 2013/14 to 2022/23 on:
 - a) The program of expenditure that was actually funded by the special variation and the reasons for any significant differences from the program listed in IPART's determination; and
 - b) The outcomes achieved as a result of the special variation.
- 3. The council reduces its general income for the 2023/24 rating year by:
 - a) \$691,640 (Initial Reduction Amount); and
 - b) The cumulative additional income derived for the 2014/15 to 2022/23 rating years on the application of:
 - Any special variation percentage approved under section 508(2) or 508A of the Act for the council for each rating year during the period 2014/15 to 2022/23; and
 - Any general variation percentage approved under section 506 of the Act for the council for each rating year during the period from 2014/15 to 2022/23,

to the 'Reduction Amount'.

Reduction Amount - means the Initial Reduction Amount as increased by the additional income derived for each previous rating year relating to the Initial Reduction Amount.

4. The Council reports to the Office of Local Government, Department of Premier and Cabinet, by 30 November each year on its compliance with these conditions for each rating year over the period from 2013/14 to 2022/23.

City Centre Capital Works Program 2014/15 (continued)

The Coffs Harbour City Centre Masterplan works program continued in 2014/15 with significant consultation and architectural design to prepare concept designs for the City Square project, one of the key infrastructure improvement projects in the 10-year program of works. The concept plans were placed on public exhibition and key stakeholder consultation meetings were held with retailers, property owners and user groups to refine the concepts. Council approved the concept plans to proceed to detailed design. The Castle Street carpark upgrade, with a solar-panel rooftop array to power the building's new lifts and amenities, and landscaping works were completed in early 2015 and works started on the new transport interchange and landscaping works in Park Avenue.

Consultation and preliminary planning commenced for the Duke Street bypass and the Harbour Drive/Gordon Street traffic lights project. Consultation began with stakeholders regarding timing for these two traffic projects and the City Square works program. The Masterplan Committee continued to liaise with retailers and property owners regarding a range of City Centre issues and engaged with retailers to market the Centre and to host several major events, including the official welcome to the NSW Blues State of Origin side in City Square, and the annual Christmas Spectacular, which involved the unveiling of a new giant Christmas tree and decorations for the City Centre.

Other activation planning during the financial year included hosting the World Rally Championships exhibition in City Square, and planning and promotion of the Anzac Day 100th anniversary commemorations in the City Centre. Regular activations were organised with a Cuban dance instructor to introduce community dancing in the City Square on Thursday nights during Spring and Summer. Social media marketing of the City Centre was expanded with a new e-Newsletter, and the Committee initiated a monthly feature of editorial promoting the Centre in the Coffs Coast Advocate newspaper. Planning continued for the relocation of existing shade sails and for the installation of new shade sails at various locations.

With much of the planning and design work either completed or close to completion, Council and the Committee are now placed to complete significant infrastructure works in 2015/16, including the Duke Street bypass, installation of traffic lights at the Harbour Drive and Gordon Street intersection, the revitalisation of City Square, and the shade sail relocation and construction work. Proposed major events in 2015/16 include the return of the NSW Blues to the City Centre, the reinstatement of the Carols by Candlelight to Brelsford Park, the Christmas Spectacular and regular summer activations in City Square.



Funding For the Future - Financial Sustainability (2014-2024)

Council requires additional funding to achieve a sustainable level of service in terms of its infrastructure. To maintain current infrastructure condition and avoid continued deterioration over time Council must spend an estimated \$6.2M over and above current funds for asset repair and renewal per annum.

On 3 June 2014, Council received approval from the Independent Pricing and Regulatory Tribunal (IPART) for a special variation of 7.9% for Coffs Harbour City Council for 2014/15.

The approval was subject to the following conditions:

- 1. That Council uses the additional income for the purposes of funding a program maintenance, rehabilitation and renewal of infrastructure.
- 2. Council reports in its Annual Report for the period 2014/15 to 2023/24 information on the total income received, expenditure per project/program and outcomes achieved.

This special variation is a key element of Council's funding strategy to ensure the sustainable management of Council's infrastructure assets. All additional revenue generated by this rate variation will be used to fund additional asset maintenance and renewal works to close the annum shortfall in this expenditure to support the delivery the services desired by the community.

2014/15 Outcomes Achieved

- Roads Maintenance funds used to address a backlog of sealing maintenance works across the Local Government Area.
- Asset Management used to ascertain scope required on priority schedule of works through geotechnical and similar investigations.
- Building Maintenance numerous projects undertaken including maintenance of surf towers at Red Rock, Sawtell and Coffs Harbour, air conditioning at Jetty Memorial Theatre, roof flashing at Sportz Central, repainting of libraries at Coffs Harbour, Toormina and Woolgoolga, repair of Council administration building box gutters and upgrade of the library security.
- Roads Rehabilitation utilised for road pavement renewals at Bonville Headland, Bonville Street, Fitzgerald Street, Jordan Esplanade, Newman Street, Gross Michel and Elwick Place.
- Transport Assets Renewal used to install guardrails at Graham Drive and Hogbin Drive, to reseal Castle Street and Korora car parks and to help address the backlog of kerb and footpath renewals across the LGA.
- Recreation Services Asset Renewal used to address urgent works including Coffs Creek boardwalk retaining wall, seal Botanic
 Gardens track, playground renovations at Graff Park, Plateau Park, park near Pet Porpoise Pool, Coramba, Jane Circuit, Argyll Street,
 Myuna Place, Polwarth Drive and Jetty, timber beach slat access at Ocean Parade, Park Beach Surf Club, Vincent Street, Park Street
 and Wonga Parks, cycleway behind Nana Lane depot, replace bridge at Thompsons Road dog exercise area, BBQ replacements at
 Boronia Park and Mullaway.

In 2014/15, Coffs Harbour City Council did not undertake any capital works projects within the scope of the above guidelines.



Overseas Visits

Local Government Act 1993 - Section 428 (4) (b) Local Government (General) Regulation 2005 - Section 217 (1) (a) 1 July 2014 to 30 June 2015.

Coffs Harbour City Council was represented in one overseas activity in 2014/15.

The Mayor, Cr Denise Knight, Cr Rodney Degens and the General Manager, Steve McGrath visited Japan as part of an official delegation from 31 August 2014 to 3 September 2014 at the invitation of the Sasebo City Council. This was on the occasion of the 25th Anniversary of the Sister City relationship between Sasebo and Coffs Harbour.

Council formally endorsed the delegation proposal at its meeting on 27 February 2014. A report to that meeting noted that while in Japan the delegation would aim to strengthen the existing Sister City relationship from both a social and economic perspective by exploring a range of opportunities for business, environmental, educational and cultural exchange.

The delegation attended a variety of meetings during the visit including the Mayor and Officials of Sasebo City, cultural site visits, Sasebo Hospital, a school linked to the educational exchange program, recycling/energy facilities and a Japan-Australia Society function. An opportunity also existed for the delegation to meet informally with the Australian Ambassador to Japan.

For 2014/15, the total cost of the delegation's visit to Sasebo was \$10,437.03.

Activities Undertaken to Implement Council's Equal Employment Opportunity Management Plan

- Council continued with training and development for all staff. The Education Assistance Program continued throughout the year to assist staff to complete higher education related to their positions within Council.
- Council supported staff with disabilities throughout the year, providing equipment needs and flexible employment where required.
- Support and encouragement was provided for Aboriginal and Torres Strait Islander (ATSI) staff to participate in National Aboriginal and Islander Day Observance Committee (NAIDOC) celebrations and take a NAIDOC-related day off work.
- A 'pilot' cultural competency training module was facilitated for a number of Council customer service and community development staff. This program received positive feedback and is under consideration for roll-out Council wide.
- Information on the Australian Government's interpreting subscription service (TIS) was actively provided to customer service staff. This free service aids effective communication for customers of Council who have difficulty communicating in English.
- Council continued to actively support staff with mental health issues including support of "RU OK?" Day.
- Council entered a team in the Local Government Managers Australia (LGMA) management challenge which is an international challenge

- Individual coaching was provided for staff seeking assistance with interview skills, with emphasis placed on staff with special needs and those from Aboriginal and Cultural and Linguistically Diverse (CALD) backgrounds.
- Council continued Code of Conduct Training for staff and volunteers, ensuring all these groups were familiar with the code and the appropriate behaviour required in the workplace in relation to ethics, bullying and harassment and respect for staff and diversity. The course has now been uploaded to an e-learning platform to ensure accessibility for volunteers of Council. This e-learning program has had strong uptake for volunteers and committee members who are unable to attend face to face training during regular business hours.

<u>Overview</u>

Coffs Harbour City Council Ranger Services has been active in Companion Animal Management during 2014/15. The main focus has again been to apply a steady and constant approach toward companion animal management and owner responsibilities when taking their pets into public places and/or not properly restraining them within their properties to prevent their animals escaping. There has been a decrease in dog fines issued during the reporting period in comparison to the previous reporting period with the reduction primarily attributable to reduced resource availability during the latter part of the year.

Regular programs ("Dog Blitzes", "Microchipping and Registration Follow Up") have been run throughout the year, focussing on breaches of control requirements for all dogs in public places and non-identified and unregistered Companion Animals. These programs have taken the form of very high profile patrols during business hours and out-of-hours periods. These blitzes have been promoted on occasions via media coverage. During the period Council's Ranger Services handled more than 1,691 companion animal complaints.

Dog Attacks

There were 107 reported dog attacks in 2014/15, a seven percent increase on last year's figures and a 23% increase on 2013/14 (In 2013/14 there were 100 reported dog attacks; in 2012/13 there were 84 reported dog attacks.) It is noted the incidence of dog attack has been on the increase over the last three years.

Dog attacks reported during this period varied in severity, from dogs acting aggressively without biting, through to several incidents which required hospitalisation of the casualty. The majority of incidents were minor.

A number of dangerous dogs were destroyed as a result of these reported incidents (13 dogs in total destroyed).
