### COFFS HARBOUR CITY COUNCIL DEVELOPER CONTRIBUTION RATES BY LOCALITY

#### BACKGROUND

This document provides the current developer contribution rates for various locations within the local government area.

Contributions are levied on the basis of a standard unit of measure known as an equivalent tenement (ET). This measure generally accords with the standard rate applicable to a residential lot or a standard residential dwelling ( with a floor area equal to or greater than 100m2).

#### CALCULATION OF CONTRIBUTIONS

Developer contributions for various types of development are calculated on the basis of the applicable ET rate as listed in the table at annexure "A" for the relevant type of development.

Contributions levied under Section 7.11 of the Environmental Planning and Assessment Act are levied on all residential development. Water and Wastewater contributions are levied on all development where Council determines that connection to these services is required.

Calculation of contributions includes the amount applicable in either table 1 or table 2 (dependant on the location in accordance with map 1) plus the contributions applicable in the relevant local area. Local area rates and catchment maps are included to assist with calculations.

The tables (table 3 to 13) for Individual release areas include all contributions applicable for that area.

Contributions are adjusted quarterly in accordance with movements in the Consumer Price Index for all groups - Sydney.

#### The contribution rates included are applicable as at

#### 1 February 2024 for December 2023 CPI OR 1 February 2024 for December 2023 RBI

Contribution rates will be applied as follows:

- the first lot in a residential subdivision is exempt from contributions
- the first dwelling on a residential lot is exempt from contributions
- the contribution rate for a medium density development is the number of dwellings multiplied by the appropriate dwelling rate minus one lot rate.

This document provides a guide to the current contribution rates applicable. For further information enquiries should be directed to Council.




# MAP 1 - Local Government Area - Catchments "A" and "B"




# MAP 2 - Woolgoolga North West and Woolgoolga West




# MAP 3 - Moonee / North Sapphire Area






### MAP 4 - Korora Rural Residential Area




MAP 5 - North Coffs Area

MAP 6 - Park Beach Area




MAP 7 - West Coffs Release Area


MAP 9 - North Boambee Valley West Release Area




# MAP 10 - South Coffs Release Area


